

Proposed Rules Changes

One of the topics for discussion at the meeting of the Standing Committee on Specialization at this year's Roundtable, will be proposed changes to the Governing Rules. The Committee follows these rules as part of the accreditation procedure. The Rules (available on the website at www.LegalSpecialists.org) cover everything from the make-up of the Accreditation Review Panels to time lines and from initial applications to appeals.

The last revision was in 2003. Since that time, all the programs have been through a re-accreditation cycle and 3 new programs have been accredited. Most of the proposed changes result from consolidating existing policies from other documents to provide consistency within the process.

Copies of the proposed rules were distributed for comment via the Specialization ListServ and will be available at the meeting at 2:00 pm on March 23rd. We welcome all comments.

The 2006 Roundtable will feature speakers from across the United States and a special guest from Edinburgh, Scotland.



Tom Elligett receives Inaugural Harry Lee Anstead Award for Board Certified Lawyer of the Year

Raymond T. "Tom" Elligett Jr. is the first recipient of the Justice Harry Lee Anstead Award for the Florida Bar's Board Certified Lawyer of the Year. The Board of Legal Specialization and Education created the award to recognize exemplary professionalism, excellence, character and commitment to The Florida Bar's certification program and to the practice of law.

ABC Hires New Executive Director

Alexandria, Virginia—The American Board of Certification (ABC) announced the hiring of Michelle Sparacino as Executive Director. Michelle will oversee the operation of the organization including board governance, committee liaison functions, and marketing to ensure a smooth transition from her predecessor, who served as Executive Director for eight of the nine years the organization has been a separate entity. In addition, she is charged with developing a marketing and communication plans to promote certification, efficient application processing and member relations. She will also redesign the ABC website in order to maintain a consistent, yet continuously evolving presence.

Prior to joining ABC, Michelle enjoyed a successful, 17-year career in higher education, primarily in academic health as the director of admissions for several prominent

graduate schools. She also served, most recently, as the assistant director of The American Medical College Application Service, a program of the Association of American Medical Colleges. Michelle earned her B.A. in Middle Eastern History from the University of Maryland at College Park, and studied Education Policy in The George Washington University's master's program. She will use her application processing, marketing, and education experience to advance the vision and goals of the American Board of Certification. "With my familiarity with the medical field, I am aware of the vital role credentialing and specialization play in the health of an industry and in the public's trust. My goal is to use that understanding and experience to advance ABC's mission to promote certification in the legal profession," said Michelle, who became the new Executive Director on January 3, 2006.

Bob Bernstein Named President of American Board of Certification

Pittsburgh, Pennsylvania—Robert S. Bernstein has a very full plate for 2006. In addition to his duties as managing partner of Bernstein Law Firm, P.C., the lauded attorney has just become president of the American Board of Certification (ABC). Recent changes in bankruptcy law make his new position more "high profile" than ever.

Mr. Bernstein has served as president-elect of this organization for the past year. He previously spent two years as treasurer, and before that served as the chair of the Standards Committee, which reviews attorneys' applications to become certified.

"One provision of the new Bankruptcy Law states that board certification is a factor the court can take into account when awarding fees to counsel," explains Mr. Bernstein. "The law change also requires that we start testing under the new law in 2006. These two developments resulted in a significant spike in the number of applications for certification."

"Assuming many of these applicants complete the requirements, the ABC will have over 1,000 certified attorneys," he adds. "That is an accomplishment that shows the acceptance and importance of certification."

New Jersey Applications Available

Applications for Civil and Criminal Trial Attorney Certification, Matrimonial Law Attorney Certification, and Workers' Compensation Law Attorney Certification are now available to determine eligibility for examinations given in 2006.

The deadline for submitting a completed civil and criminal application is February 28, 2006 by postmark or hand delivery. The deadline for filing a completed matrimonial or workers' compensation application is March 31, 2006 by postmark or hand delivery.


The information sharing session has become an annual event as well. In the past, members of the certification community have shared marketing plans, forms, and
