What's Going on in Minnesota?

Minnesota Lawyer's Mutual has announced that it is filing for approval to provide a 5% rate credit on malpractice policies for Certified Specialists. MLM is the Minnesota State Bar Association endorsed provider of professional liability coverage. If approved, the 5% rate credit will make Minnesota the second jurisdiction to provide a state-wide discount for Certified Specialist's malpractice insurance.

Last December, after seven months of study, the Supreme Court-appointed a Taskforce on Legal Certification in Minnesota and published its conclusions. Among them, it found;

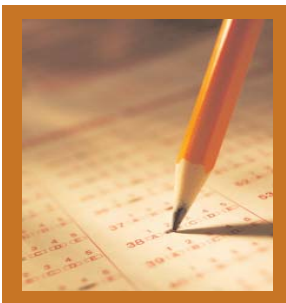
- The public benefits from having a specialist program where credentials can be determined and monitored by a local, independent board and specialist claims can be verified.
- The public expects the court or the profession to determine the qualifications of specialists and generally agrees with the criteria currently in use [by the MSBA Certification programs].
- The MSBA and the Minnesota State Board of Legal Certification (separate entities in Minnesota) both had a responsibility to explore ways in which to create new specialty areas with additional specialists in order to support legal specialization for the benefit of the public.

MSBA staff has recommended to Association Governance that two things occur in response to the Taskforce Report:

1. A staff position be funded for one year to develop at least two new specialty areas. Two MSBA Sections have already voted to become certifying agencies - Criminal Law and Labor & Employment - but without staff assistance have found it difficult to proceed with the accreditation process.
2. A Certification Standing Committee be formed and charged with developing an ongoing marketing plan to increase awareness of the value of legal specialist certification among MSBA members and the public.

The Assembly will vote on these staff recommendations in mid-December, 2007.

Gena Berglund has accepted the position of MSBA Certified Legal Specialists. Gena is an attorney with experience in both the private and public sectors. Meaghan Harper has become Director of MSBA Section Services. Since the MSBA Sections have served as Certification Accrediting Agencies, she will remain involved in publicizing efforts and general support for the existing certification programs as well as supporting the development of further section accrediting agencies.



The MSBA Real Property Specialist examination will be offered February 23, 2008. The examination is offered only every other year. The application period opens October 1st of the preceding year.
