Also, on May 7, 1 - 6:30 p.m., the Section of Taxation will feature a workshop to train lawyers representing low-income taxpayers in IRS collection matters. Sponsored by the section's Low-Income Taxpayer and Pro Bono Committees, the workshop will focus on trends in IRS collections as they relate to low-income taxpayers, and will describe typical collection notices and issues taxpayers may face, as well as the importance of financial analysis in collection. Separate registration is required to attend the workshop.
