On Saturday, October 27 volunteers from the Young Lawyers Section (YLS) of The Chicago Bar Association headed out to the suburb of Hoffman Estates to write 33 wills for the firefighters and their spouses of Station 24 as part of its new "Wills for Heroes" program. The Wills for Heroes Foundation developed the program shortly after September 11, 2001 and it has recently become a national initiative of the Young Lawyers Division of the American Bar Association (ABA/YLD). The program has volunteer lawyers go into firehouses, police departments and other venues to draft simple estate plans at no cost to the

first responders.

The program was initiated in Illinois by YLS Chair **Bill Oberts** and implemented by YLS Special Projects Coordinators Sal Cicero and Maureen Duffy along with the help of the Wills for Heroes Foundation.

"I regularly represent firefighters and police officers. When I learned of the program, I thought it was a great way for us to give back to those who risk their lives daily for our benefit," said Oberts. "The ABA/YLD was very supportive of our efforts to implement the program in Illinois. We hope to offer the program to Chicago area firehouses and other departments. We'll go department to department to help our first responders."

The YLS received great feedback from

the Hoffman Estates Fire Department. Fire Department Chief **Jeffrey Jorian** advised that "The process was painless and very efficient" and "It couldn't have been a more pleasurable experience!"

This was the first Wills for Heroes program implemented in Illinois. The YLS hopes to hold many more programs to help those who devote their lives to serving their communities and are prepared to pay the ultimate price in the line of duty.
