Stan Bernstein served as a U.S. bankruptcy judge for more than 12 years, first from 1982 through 1984 in Flint and Detroit, Michigan, and from 1996 through 2007 on Long Island, New York, before retiring to teach full time as a law professor at Atlanta's John Marshall Law School. There he regularly offers courses on sales and secured transactions, bankruptcy, and equitable remedies. Recently, with co-authors Susan Seabury and Jack Williams, he has published two major Law Review articles on the application of the bankruptcy court's duties for admitting or rejecting testimony on financial matters in bankruptcy cases. Judge Bernstein was raised and educated in Boston, Massachusetts. He is a graduate of the Boston Latin School (founded in 1635), Brandeis University (B.A.), the University of Chicago (M.A., political science), Harvard University (Ph.D., political science), and Rutgers (J.D.) He was admitted to the bar of the states of Ohio, Michigan, California, Arizona, and Massachusetts, and focused primarily on business bankruptcy law and commercial finance for 35 years, including his federal judicial service.

Susan Seabury holds a bachelor's degree in economics from Vanderbilt University, an MBA from the Owen Graduate School of Management at Vanderbilt University, and a juris doctorate (cum laude) from Georgia State University College of Law. She is a member of the Georgia Bar, several federal bars, the Atlanta Bar, the American Bankruptcy Institute, the Association of Insolvency and Restructuring Advisors, and the International Women in Restructuring Confederation. Ms. Seabury is the author of several books and articles, and often speaks on business bankruptcy topics. She practices law, concentrating on commercial bankruptcy-related issues, and provides financial advisory services in bankruptcy and insolvency matters. Jack Williams is a professor of law at Georgia State University where he teaches and conducts research in numerous areas, including
