Prior to taking any enforcement action, the Director may issue subpoenas or investigative demands to investigate possible CFA and UDTPA violations.	795

(2) The Director also has “the authority to promulgate rules and regulations deemed necessary or appropriate to implement or clarify [the CFA and UDTPA] or otherwise to carry out the purpose of [the CFA and UDTPA].” Courts must provide substantial deference to these rules. To date, the Director has not promulgated any rules related to the CFA or UDTPA other than a procedural regulation related to the administrative proceedings mentioned above. 797
