## Free legal assistance available for disaster survivors in Cameron and Hidalgo counties

**July 20, 2018** — A toll-free legal aid hotline is available to survivors of the federally declared disaster areas in **Cameron and Hidalgo counties** for the storms and flooding that occurred June 18-22, 2018. The American Bar Association Young Lawyers Division, State Bar of Texas, and Texas RioGrande Legal Aid are working together to provide legal resources to people and businesses affected by the disaster.

Survivors facing legal issues who are unable to afford a lawyer may call **(866) 757-1570** toll-free to request:

- Assistance with securing FEMA and other government benefits available to disaster survivors;
- Assistance with life, medical and property insurance claims;
- Help with home repair contracts and contractors;
- Replacement of wills and other important legal documents destroyed in the disaster;
- Assistance in consumer protection matters, remedies and procedures;
- Counseling on mortgage-foreclosure problems; and
- Counseling on landlord-tenant problems.

Survivors should be aware that there are limitations on disaster legal services. For example, assistance is not available for cases that will produce a fee (i.e., those cases where attorneys are paid part of the settlement by a court). Such cases are referred to a local lawyer referral service.

Individuals who qualify also may use [texaslegalanswers.org](http://texaslegalanswers.org) — an online Q&A-style service where individuals can pose specific questions related to civil legal issues and have them answered online by volunteer attorneys. Texas Legal Answers is operated by the State Bar of Texas in conjunction with the American Bar Association.

### **Background**

On July 6, 2018, a Major Disaster Declaration was issued for the state of Texas, making federal funding available for to individuals and business owners in **Cameron and Hidalgo counties**. To register with

FEMA, and if eligible, apply for federal and state disaster assistance, register online at [www.DisasterAssistance.gov](http://www.DisasterAssistance.gov), via smartphone, or Web-enabled device at [fema.gov](http://fema.gov). Applicants may also call 800-621-3362 or 800-462-7585 (TTY) seven days a week from 6 a.m. to 10 p.m. (CT). Applicants should be prepared to provide basic information about themselves, insurance coverage, and any other information to help substantiate the loss.

**The deadline to register with FEMA is September 4, 2018.**

### **Barratry or Improper Soliciting**

The State Bar of Texas reminds the public that in many cases it is a crime in Texas for a lawyer or someone representing a lawyer to contact a person for purposes of legal representation if the person has not first requested the call or personal visit. The contact is not illegal if the attorney is not seeking payment or has a preexisting professional-client or family relationship with the person being contacted.

If you witness something you believe to be improper solicitation, or barratry, please get the name and phone number of the person making contact and report it to your local law enforcement authority or the State Bar Chief Disciplinary Counsel's Office toll free at **(866) 224-5999**.
