**KENNETH BERLIN** is General Counsel, Coalition for Green Capital. Previously he was a partner with Skadden, Arps, Slate, Meagher & Flom LLP in Washington, DC, where he headed the firm's Environmental and Climate Change practices. He has extensive experience in advising clients on climate change, and has spent considerable time negotiating environmental contract provisions and in handling environmental due diligence investigations, representing hundreds of companies in business transactions. He played a prominent role in the North American Free Trade Agreement (NAFTA) and the General Agreement on Tariffs and Trade (GATT) negotiations. Before moving to private practice, he was section chief, Wildlife Marine Resources Section, Environment and Natural Resources Division, U.S. Department of Justice. Mr. Berlin has written extensively on greenhouse gas issues, international trade and the environment, and clean coal technology, among other environmental and resource issues, and has lectured widely on climate change. He was listed in the first tier of environment (transactional) attorneys in *Chambers America's Leading Lawyers for Business 2010* and, among other honors, has served as Chairman of the Board of the Environmental Law Institute and as Chairman of the Board of Trustees of the RARE Center for Tropical Conservation. He continues to be actively involved in legislative and regulatory debates on energy and climate change at state, national, and international levels, and is senior advisor and project lead for the Governors' Climate and Forests Task Force (GCF), [www.gcftaskforce.org](http://www.gcftaskforce.org). His books have been translated into over forty languages, and he has served on the boards of various public organizations including the Institute of Public Policy Research. He was educated at the University of Hull and the London School of Economics and holds honorary degrees or comparable awards from over twenty universities.

**PETER PEARSON** is Director of the Low Carbon Research Institute (LCRI) of Wales, based at Cardiff University. LCRI is a multi-disciplinary collaboration of research teams across six Welsh Universities, with a £50 million research portfolio. Professor Pearson previously was Director of the Centre for Energy Policy & Technology (ICEPT) and Professor of Energy & Environmental Studies at Imperial College London, where he now is a Visiting Professor. His research addresses long run energy technology and fuel transitions and their policy implications. He has been Chairman of the British Institute of Energy Economics, a member of the European Commission's 6th Framework Programme Advisory Group on Energy, and since 2001 an expert adviser/consultant to the World Bank Inspection Panel. He was Specialist Adviser to the 2007-08 House of Commons Select Committee Enquiry into Renewable Electricity Generation. In 2007, he was invited to give the Queen's Lecture at the Technical University of Berlin, as successor to the 2006 Lecturer, Lord Rees, President of the Royal Society. His paper, 'Seven Centuries of Energy Services: the Price and Use of Light in the United Kingdom (1300-2000),' written with Roger Fouquet, won the 2006 Campbell Watkins Prize for Best Paper in the Energy Journal. Professor Pearson holds B.A., M.Sc. and Ph.D. degrees.

**BENJAMIN J. RICHARDSON** is a Professor and Senior Canada Research Chair in Environmental Law and Sustainability, University of British Columbia Faculty of Law. His principal research focuses on socially responsible investment and its regulation as a means of promoting environmentally sustainable development. His scholarship also includes Aboriginal peoples and the environment, climate change law, and international and transnational law. He has published extensively, including most recently, *Climate Law and Developing Countries: Legal and Policy Challenges for the World Community* and *Socially Responsible Investment Law: Regulating the Unseen Polluters*. Previously, he was a Professor at Osgoode Hall Law School, York University; a Senior Lecturer, law faculties at University of Manchester (UK) and University of Auckland (New Zealand); and a Visiting Professor, Faculties of Law, Universities of Stockholm, Copenhagen, Milan, and Iceland. He is a frequent speaker on socially responsible

investment, climate change, and sustainable development. Among other honors, Dr. Richardson is a member of the Governing Board of the IUCN Academy of Environmental Law; received an Award of Research Excellence, UN Principles of Responsible Investment Academic Conference, for best paper; and is the recipient of numerous grants supporting research, conferences, and other initiatives. He holds a B.A. and LL.B. from Macquarie University (Australia) and a Ph.D. from Australia National University.

**JAMES W. RUBIN** is Counsel in the global Energy, Transport and Infrastructure sector, SNR Denton US LLP, focusing on environment and natural resources, including climate change law and policy, and federal, state, and citizen enforcement matters, particularly related to the energy sector.
