### Message from the Chair

The last few months have been busy ones for the Section, with programs dealing with representation of federal employees in EEOC proceedings, due process for veterans, the outlook for transportation legislation, hot topics for federal lobbyists, consumer product safety law and the resounding success of the Homeland Security Institute on March 3-4 (with well over 300 attendees). The next few months promise to be equally productive for the Section with various projects underway, including a study of agency compliance with the OMB's Good Guidance Practices Bulletin and preparation of comments on proposed FCC changes to their ex parte practice and other procedural rules, along with the Rulemaking Institute now scheduled for June 1 in Washington at the Capitol Hilton. Meanwhile, the Section's blue-ribbon Task Force on Lobbying Reform is focusing on a variety of possible changes to federal law, including new disclosure obligations, earmark reform, and possible restrictions on

lobbyist involvement in political fundraising. The Section will hold its Spring Meeting at Nemacolin Woodlands in Farmington, Pennsylvania. On Friday, May 14, there will be five programs offered: transparency and public accountability in health care policymaking in third world countries; global administrative law and the potential for Section initiatives in that area; opportunities for international missions involving administrative law for interested Section members; issues presented by the nuclear plant licensing process; and the constitutional challenge to the Sarbanes-Oxley Act of 2002 under the Appointments Clause and separation-of-powers principles (a decision by the Supreme Court in the case is expected by June). Business meetings of the Section will take place on the mornings of May 15 and 16, to include an ambitious agenda including presentation and Council consideration of a proposed three-year strategic plan for the Section. Saturday afternoon will be available for a multitude

of indoor and outdoor activities for all ages—indeed we hope that many attendees will be able to bring their families to Nemacolin for a very enjoyable mini-vacation. A more detailed description of the programs and activities will be forthcoming in the next week or so.

Finally, planning is well underway for the Annual Meeting in San Francisco that will feature, among other things, a Saturday wine country tour capped by a multi-course/multi-wine meal at the famous Mondavi Winery. We hope that many Section members attending the Annual Meeting can join us for this wonderful event as well as the CLE programs (including one dealing with the *Citizens United* case on corporate political spending) and the Council Meeting.


### Lobbying Institute: Hot Topics for Lawyer-Lobbyists




