### SECTION MEMBERSHIP DISCOUNT

### **TAX INFORMATION**

Membership dues are not deductible as a charitable contribution for income tax purposes, but may be deductible in part as a business expense. The ABA estimates that 2 1/2% of your total membership dues is allocable to lobbying activities of the Association, and therefore not deductible for income tax purposes as ordinary and necessary business expenses. We recommend that you consult your tax advisor.
