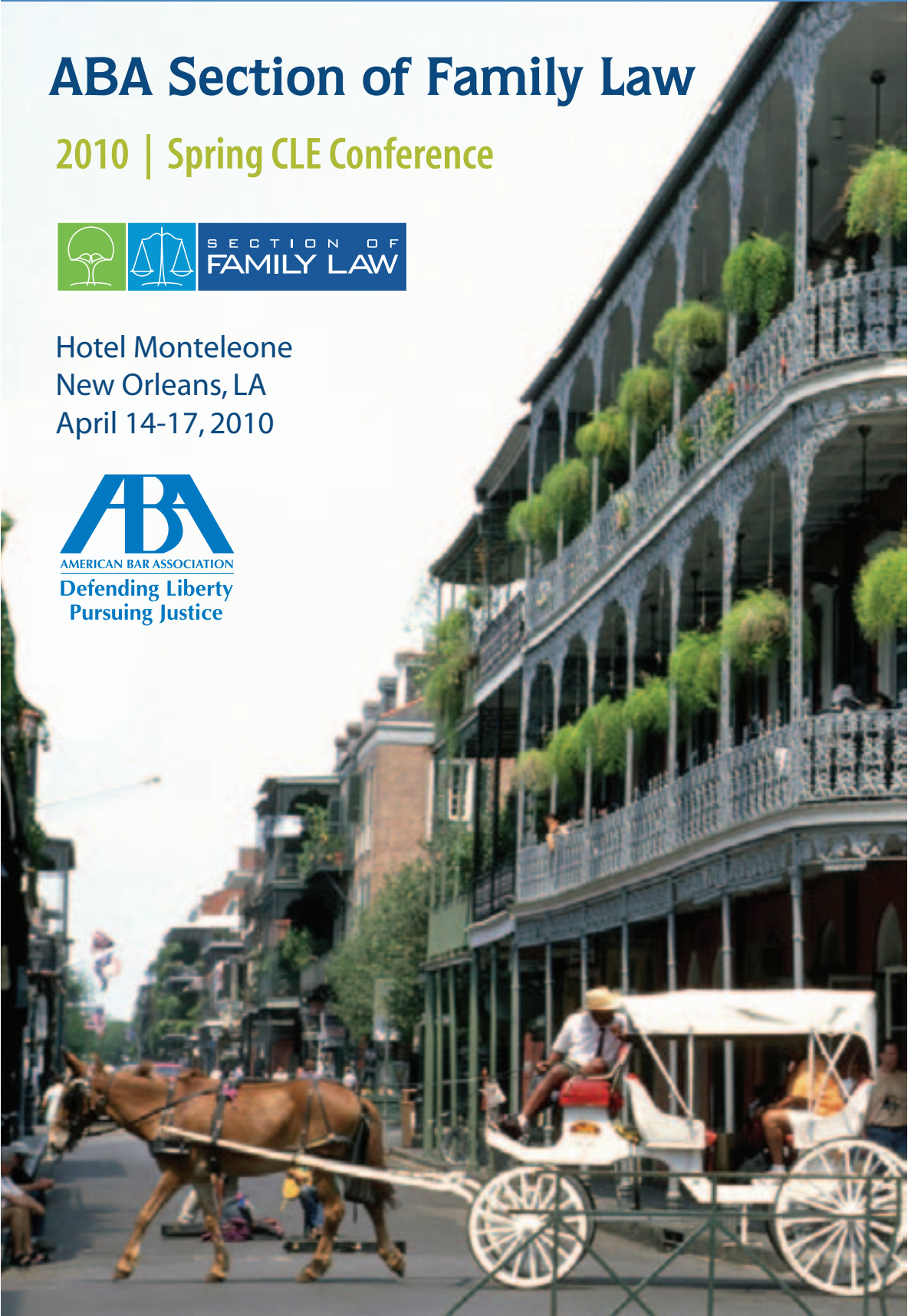

NEARBY AIRPORTS & TRANSPORTATION

New Orleans is served by most major airlines through the Louis Armstrong New Orleans International Airport (MSY). The airport is approximately 15 miles (25 minutes) from the hotel. The Airport Shuttle is another option: the one-way rate is approximately \$20 and round trip is \$38 per person. Reservations can be made on Hotel Monteleone's "Map & Directions" webpage.

REGISTRATION FEES

The early bird registration fee, postmarked by March 12, 2010, is \$450 for ABA Section of Family Law members. This fee covers all CLE Programs, access to downloadable materials prior to the conference, breakfast each day and networking receptions on Wednesday and Thursday evenings as well as the Chair's Suite receptions on Wednesday and Thursday evenings. Registration increases to \$525 after March 12, 2010, so don't delay.
