Public Contract Law Section**In the Wake of *Tecom*: Is it Possible to Recover the Cost of Third-Party Litigation Settlements?**

March 9, 2010 (12:00 p.m. - 1:30 p.m. Eastern Time)

In its *Tecom* decision, the U.S. Court of Appeals for the Federal Circuit held that the costs of defending and settling third-party litigation alleging conduct that, if proven, would violate a contract clause, are unallowable unless the contractor obtains a determination from the contracting officer that the litigation had “very little likelihood of success.” This Teleconference/Webinar will examine the validity of the Court’s ruling that the costs resulting from breach of contract are *per se* unallowable and that costs can be unallowable even if they bear no relationship to any costs made unallowable in the Legal Costs Principle. The Webinar will also examine the Court’s conclusion that the *Tecom* ruling is compelled by the regulatory history of the FAR cost principles. The Teleconference/Webinar will discuss whether the Court’s decision undermines previously settled law that encouraged settlement of third-party litigation as being in the interest of both the government and contractors.
