

ALL ABOUT I KNOW MY STUDENT RIGHTS

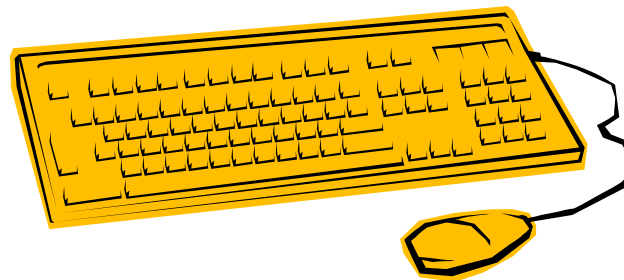

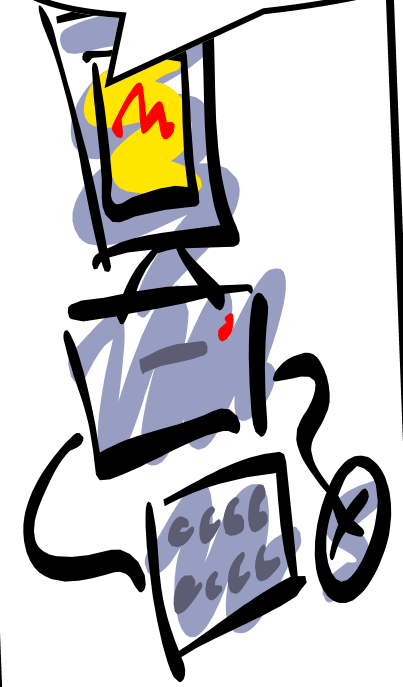
