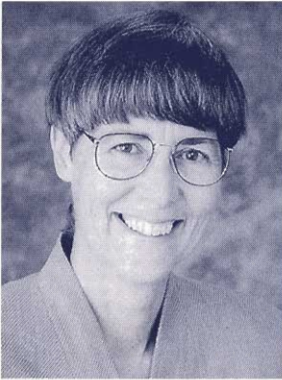


Jean E. Dubofsky, P.C.

When Jean Dubofsky was appointed to Colorado's Supreme Court (the first woman and youngest person), it was called "good news for Colorado and good news for justice" by then Vice President Walter Mondale. Her career, one of advocacy and action on behalf of women, the poor, and others excluded from equality in the political and legal process, includes serving as lead counsel in the successful challenge to the constitutionality of a Colorado constitutional amendment preventing gays and lesbians from obtaining governmental redress for discrimination on the basis of sexual orientation.



After serving as Mondale's legislative assistant from 1967-69, she moved to Colorado and began her distinctive, exemplary service in the legislative, executive, and judicial arenas to eradicate long-held barriers to women in a state known for its male-dominated institutions. She has served the underserved, the law, and society, in capacities traditionally denied to women and has opened doors for other women to enter. Her career path has taken her from the U.S. Capitol to Colorado's Rural Legal Services (1969-72) and the Legal Aid Society of Metropolitan Denver (1972-73), to partnership in private practice at Kelly/Dubofsky/Haglund & Garnsey (1973-1975) to Deputy Attorney General of the State of Colorado (1975-1977).

Ms. Dubofsky was of counsel to Kelly/Haglund/Garnsey & Kahn (1977-79), when she was appointed Justice of the Colorado Supreme Court, an appointment she held until 1987. She then entered academia, as visiting professor at the University of Colorado Law School (1987-88) and adjunct professor in the Women's Studies Department, the University of Colorado at Boulder (1988). She was again of counsel to Kelly/Haglund/Garnsey & Kahn, Denver (1987-90), and to Williams, Trine, Greenstein & Griffith, Boulder (1990-91), when she became a sole practitioner.

She belongs to the American, Colorado, Colorado Women's, and Boulder County bar associations. She was chair of the Governor's Task Force on Insurance Reform (1989) and board member of the State of Colorado Commission on Judicial Performance (1989-90).

Jean Dubofsky received the Colorado Women's Bar Association Mary Lathrop Trailblazer Award for "dedication to public service and public interest law" (1993), the Boulder County Bar Association President's Award of Merit for "...represent[ing] the rights of others...with the highest standards of the legal profession" (1992-93), and the ACLU Carle Whitehead Memorial Award for "exceptional commitment and dedication to civil liberties and the State of Colorado" (1993).

Jean E. Dubofsky earned her A.B. from Stanford University (1964) and her LL.B. from Harvard Law School (1967). She and her husband, Frank N. Dubofsky, are parents of two sons.
