### BLI 2015 Registration To Open; Scholarships Available

Registration will open soon for the ABA's signature conference for bar leaders. More than 300 are expected to attend the [2015 Bar Leadership Institute](#), to be held March 11-13 at the Chicago Marriott Downtown Magnificent Mile. The meeting will prepare incoming bar leaders to guide their associations, with a focus on leadership, governance, and communications skills.

The Magna Carta exhibit has reached the heartland. After a successful debut in Boston, the traveling exhibit [Magna Carta: Enduring Legacy 1215-2015](#), has stopped in Indiana. The Indiana State Bar Association will host the exhibit through October 9 at the Indiana Statehouse in Indianapolis, along with a special CLE program focused on Magna Carta and the rule of law.

From October 1-24, the University of Michigan Law School also will host the exhibit, along with programming featuring a prominent British medieval scholar.

The exhibit, sponsored by the ABA and the Law Library of Congress, features a series of banners that tell the story of the historic document and its impact on the rule of law.

The exhibit is being displayed at law schools, courthouses, bar centers, law libraries and other venues around the U.S., and will make an international stop in June 2015 at the ABA's [London sessions](#).

### **ABA Releases Revised Law School Standards**

The ABA has released [new standards and rules for the approval of law schools](#). The rules went into effect August 12, though law schools are being given time to implement them.

### **ABA Seeks HOD Agenda Issues**

Highly competitive, the program fielded more than 700 applications last year. Volunteers are needed to help prescreen interviews, serve as panelists at program orientations, and participate in local mentoring programs.
