

## **ABA Criminal Justice Section EDITORIAL POLICY**

The American Bar Association's Criminal Justice Section encourages in-depth writing and seeks to publish the highest quality of content and materials. The Criminal Justice Section encourages the expression of a variety of viewpoints on undecided or contested issues and seeks to publish thoughtful analysis when presented in a civil and courteous manner.

The Criminal Justice Section grants its authors a wide latitude of expression and encourages thoughtful presentation of a wide variety of viewpoints but reserves the right to edit and, if necessary, revise any submission before publication to conform to the ABA's Editorial Requirements and Procedures and the Criminal Justice Section's policies and procedures.

All publications are reviewed and approved by the Criminal Justice Section's Book Board (books), the *Criminal Justice* Magazine Editorial Board (for *Criminal Justice* magazine only), or the CJS staff (for *Criminal Justice Section Newsletter* and in-house publications) before publication.

### **Disclaimers of ABA Opinion and Legal Advice:**

The materials contained in all CJS publications represent the opinions of the authors and editors and should not be construed to be those of either the American Bar Association or the Criminal Justice Section unless adopted pursuant to the bylaws of the Association.

The materials contained in CJS publications are not intended as and cannot serve as a substitute for legal advice. Readers are encouraged to obtain advice from their own legal counsel. These materials and any forms and agreements are intended for educational and informational purposes only.

### **Adherence to Business Conduct Standards and Conflicts of Interest:**

By submitting a work for publication, all authors acknowledge they have reviewed the ABA Business Conduct Standards (BCS) and agree to comply with all applicable provisions. The Criminal Justice Section requires that all conflicts of interest, such as those identified in the ABA Business Conduct Standards, be disclosed in any content or material submitted for publication.

At a minimum, the Criminal Justice Section requires that any content or material submitted for publication contain the identity of all authors and their professional affiliations, both to establish their qualifications and to reveal any potential conflicts of interest.

### **All Submissions Must Respect Intellectual Property Rights of Others:**

Authors must agree not to submit any content that infringes upon or violates the copyrights, trademarks, or other intellectual property rights of any person or organization.

### **All Authors Must Sign an ABA Publication Agreement:**

Before publication, all prospective authors must sign an ABA publication agreement, and all publication agreements are required to be reviewed and approved by the Criminal Justice Section and the ABA Office of the General Counsel (GCO).

### **Submission May Not Contain Defamatory Material and Must Meet ABA's Standards of Civility:**

The Criminal Justice Section will not publish any content or material that is defamatory or violates the law. The Criminal Justice Section supports the expression and publication of a variety of viewpoints, including those that are controversial or unpopular, but only when done in a civil manner. Decisions to publish articles that express unpopular opinions or encourage controversy are within the Criminal Justice Section's discretion.

### **No Partisan Or Political Advocacy Content:**

The Criminal Justice Section will not publish any content or material that is partisan political advocacy for or against any political candidate or party; however, fair criticism, analysis and comment consistent with the policies contained within this Editorial Policy, will be considered for publication.

### **The Right To Reject Any Submission:**

The Criminal Justice Section reserves the right to reject any submission and to retract or reject any publication at any point in the publication process if there are any concerns with its content, including any content that is inconsistent with the ABA's goals and policies. The Criminal Justice Section does not guarantee publication of any submission.

### **Author Corrections After Submission:**

Authors have an obligation to correct mistakes if they discover a significant error or inaccuracy in their publication. Upon discovering such an error, the author must contact the Criminal Justice Section and identify the error. A decision on how to correct the publication will be made the Criminal Justice Section depending on the nature of the error.

### **Right of First Publication:**

For any content submitted for potential publication, the Criminal Justice Section will assume that the submitted content has not been submitted or already published elsewhere. The publication may not be submitted elsewhere while it is being evaluated by the Criminal Justice Section for potential publication. If the submission has been previously published or is scheduled to be published elsewhere, the Author must communicate that fact to the Criminal Justice Section.
